## Innovation, Resiliency, and Community Benefit

The Siskiyou Economic Development Council has stewarded a multi-year, community supported and inclusive process to develop an adaptive reuse and placemaking strategy for Yreka's historic Carnegie Library. The strategy comprises community visioning, site acquisition and development planning, architectural/engineering/historical plans, environmental assessment/remediation, permitting, and construction. Today, the project is shovel-ready, with construction beginning in March. The SEDC has successfully secured \$5 million in state, federal, foundation and local funding to complete construction and transform the shuttered landmark into an inspirational, iconic community asset.

The SEDC will repair and reintroduce Yreka's Carnegie building as a key, thriving fixture of Miner Street. Its design includes ADA accessibility and multi-purpose, adaptable convening spaces. Its programming will draw pedestrians to downtown, and serve the diverse needs of Siskiyou County's businesses, entrepreneurs, and industry leaders. It will showcase best practices in local economic development, public-private investment strategies, and business services/resources. It will stand as a physical demonstration of rural innovation and serve as a model for community resiliency. Most importantly, its careful rehabilitation will catalyze Miner Street's revitalization through business innovation.

The project, supported by a distinguished California Jobs First Pilot Award, a USDA RISE award, and community partners, will play a crucial role in bringing businesses together, and catalyzing new investment on Miner Street, while preserving Carnegie's historical significance.

## THE HISTORY

The Yreka Carnegie Library has marked the community's physical and cultural infrastructure for over 100 years. The building, was designed by W. H. Weeks and completed in 1915. It exhibits Classical Revival architecture. Today, it stands as a testament to the community spirit and efforts that brought a Carnegie library to Yreka. The landmark was added to the National Register of Historic Places in 1992.

## SISKIYOU ECONOMIC DEVELOPMENT

In 2019, the City of Yreka conducted a competitive process to lead the Carnegie Library's adaptive reuse plan. The SEDC was selected for their innovative and forward-thinking approach to the project and for their outstanding track record. The SEDC was awarded title to secure diverse funding, provide clear community benefit, contribute to Miner Street's revitalization, and include ADA accessibility standards in its design.



These distinguished awards will help Siskiyou County's communities build industry resiliency, good jobs, and local entrepreneurship that will help build a resilient rural economy for years to come.



#### DISCOVER SISKIYOU

The rehabilitated Carnegie building will serve as a featured asset of the Discover Siskiyou tourism brand. The location will inspire visitors to frequent Yreka's West Miner Historic district and will provide a new venue to support events and conferences in downtown Yreka.



#### SMALL BUSINESS DEVELOPMENT CENTER

Technical assistance to support small businesses will be a central function of the reimagined Carnegie building. Its design and programming will provide businesses with access to meeting spaces, resources and curriculum to start, grow and evolve in today's market. The location will serve as the Shasta-Cascade Small Business Development Center.

The landmark location will serve as the permanent headquarters for the Siskiyou County Economic Development Council and its team of dynamic professionals. The legacy project will save a national treasure, and catalyze revitalization of Miner Street.



# INNOVATION AND BUSINESS ENTREPENEURSHIP

The Carnegie will hold programs to support agriculture, forestry, outdoor tourism, and entrepreneurship. It will coalesce a USDA RISE program, a California Innovation Hub, and the Siskiyou Climate Collaborative, to help local businesses reach new markets and face climate challenges.
